ORDINANCE 02-2022: AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATIONS LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

**WHEREAS**, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

**WHEREAS**, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

**WHEREAS**, the Mayor and Council of the Borough of Farmingdale in the County of Monmouth finds it advisable and necessary to increase its current year 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

**WHEREAS**, the Mayor and Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$22,857.10 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

**WHEREAS** the Mayor and Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Mayor and Council of the Borough of Farmingdale, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the current year 2022 budget year, the final appropriations of the Borough of Farmingdale shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$22,857.10, and that the current year 2022 municipal budget for the Borough of Farmingdale be approved and adopted in accordance with this ordinance; and **BE IT FURTHER ORDAINED**, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and **BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division

of Local Government Services within 5 days of introduction; and

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

# EXTENDING GRACE PERIOD FOR PAYMENT OF 3<sup>RD</sup> QUARTER 2022 TAXES

**WHEREAS**, the Tax Collector has informed the Mayor and Council of the Borough of Farmingdale that the Monmouth County Board of Taxation was delayed in forwarding the necessary information for the preparation and mailing of final tax bills to the real estate taxpayers of the Borough of Farmingdale for the year 2022; and

WHEREAS, the present statute requires the imposition of late charges if 3<sup>rd</sup> quarter 2022 taxes are not paid by the 10<sup>th</sup> of August; and

**WHEREAS**, it would be unfair and unreasonable to impose a penalty for a delinquent payment when the amount of the payment is unknown.

**NOW, THEREFORE, BE IT RESOLVED**, that the Tax Collector of the Borough of Farmingdale is hereby ordered and directed, according to Public Law 1994, Chapter 72, signed July 14, 1994, that if tax bills are not delivered or mailed at least 25 (twenty-five) calendar days prior to the standard due date, then the delinquency date for 3<sup>rd</sup> quarter 2022 taxes shall be established as the twenty-fifth (25<sup>th</sup>) calendar day after the date the tax bills were mailed. The tax bills will contain the date on which interest shall start accruing.

# **RESOLUTION 68-2022**

# AUTHORIZING TEMPORARY WAIVER OF MARRIAGE AND CIVIL UNION LICENSE FEES

WHEREAS, P.L. 2022, C. 23, signed by Governor Murphy waives license fees for marriages and Civil Unions from July 1, 2022 through June 30, 2023; and

WHEREAS, Municipal Licensing Officers collect a \$3.00 (Three Dollar) fee for issuing a Marriage or Civil Union License; and

**WHEREAS,** in addition to this fee, Municipal Licensing Officers are also required to collect a \$25.00 (Twenty-Five Dollar) fee for each license, to be forwarded to the Department of Human Services for the purpose of providing shelter-related services to victims of domestic violence.

**NOW THEREFORE BE IT RESOLVED,** both of these fees are now waived for a period from July 1, 2022 through June 30, 2023. During this period, a Municipal Licensing Officer shall not charge or collect a fee for issuing a marriage or Civil Union License from an applicant.

BE IT FURTHER RESOLVED, the State shall reimburse Municipalities for license fees suspended during this period.

#### **RESOLUTION 69-2022**

# **RECOGNITION OF OVERDOSE AWARENESS DAY**

WHEREAS, addiction is a chronic disease, characterized by compulsive or difficult to control drug use despite harmful consequences; and

WHEREAS, addiction is seen by both the Centers for Disease Control and the World Health Organization as a fastgrowing epidemic that can all too easily lead to overdose and death; and

WHEREAS, in 2020, over 93,000 individuals died from drug overdoses in the United States; and

WHEREAS, New Jersey alone, 3,006 people died from drug overdoses in 2018; and

WHEREAS, as of April 30, 2022 Monmouth County alone has lost 47 persons due to overdose; and

WHEREAS, for every drug overdose that results in death, there are many more nonfatal overdoses, each taking an emotional and economic toll on the individual, their family, and the community at large; and

**WHEREAS**, addiction can fuel feelings of shame, guilt, embarrassment, depression, and hopelessness, causing individuals to resist seeking treatment and support; and

**WHEREAS**, Overdose Awareness Day is a global event held on August 31<sup>st</sup> of each year that aims to raise awareness of drug overdoses, reduce the stigma of a drug-related death, and to acknowledge the grief felt by families and friends remembering those who have died or had a permanent injury as a result of a drug overdose; and

WHEREAS, to further the goals of Overdose Awareness Day, all flags throughout the State should be flown at half-staff for the day's duration; and

WHEREAS, Overdose Awareness Day in New Jersey sends a strong message to former or current substance users, namely, that they are valued, and that overdose death is preventable.

**NOW, THEREFORE, BE IT RESOLVED** by Mayor and Council of the Borough of Farmingdale and State of New Jersey:

- 1. August 31<sup>st</sup> of each year shall be designated as "Overdose Awareness Day" in the Borough of Farmingdale to raise awareness of overdose and reduce the stigma of a drug-related death.
- 2. The Governor is respectfully requested to order flags be flown at half-staff and to issue a proclamation calling upon public Officials and the citizens of this State to observe "Overdose Awareness Day" with appropriate activities and programs each year.
- 3. This resolution shall take effect immediately.

#### RESOLUTION 70-2022 AUTHORIZE FOR AMERICAN RESCUE PLAN FIREFIGHTER GRANT

**WHEREAS,** the Borough of Farmingdale desires to apply for and obtain a grant from the New Jersey Department of Community Affairs for approximately \$75,000 to carry out a project to purchase Fire Fighter Equipment; and **BE IT THEREFORE RESOLVED**,

- 1) that the Mayor and Council of the Borough of Farmingdale does hereby authorize the application for such a grant; and,
- 2) recognizes and accepts that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, does further authorize the execution of any such grant agreement; and also, upon receipt of the fully executed agreement from the Department, does further authorize the expenditure of funds pursuant to the terms of the agreement between the Borough of Farmingdale and the New Jersey Department of Community Affairs.

**BE IT FURTHER RESOLVED** that the Chief of the Fire Department, Chief Municipal Finance Officer, Mayor and Municipal Clerk, who's signatures appear below are authorized to sign the application, and that they or their successors in said titles are authorized to sign the agreement, and any other documents necessary in connection therewith:
